Director Munn and Business Manager Kathy Bogenreif attended an Employee Law Letter training at Quarry Oaks, sponsored by Erickson Sederstrom.

The Federal contracts with EEOC and HUD look good. We have met the expectations up to this point. For our HUD contract, we needed to complete 40 cases and we exceeded that by two. We made it last year also, but partly because we finished a large group in Lexington. This year we were able to work all 40 cases from start to finish.

According to the EEOC measurement period, we should get an upward modification – we need to read and submit 50 cases in the next four months to meet our contract as is. We have the inventory of completed investigations to make this work. If there is an upward modification, we shouldn't have any trouble meeting that as well.

The EEOC Conference is in San Diego next week. Director Munn and two of the supervisors will be attending. There is still one supervisor in the office.


The all-staff meeting is to be held on July 16, 2019. The staff from all the offices will be in attendance at this meeting.

Commissioner Drumheller declared the June 14, 2019, Commission meeting ended at 11:41 a.m.


