2. Outreach Report—Unit Director, Ben Watson

Director Watson shared that the Nebraska Connects program is in its final editing stage. It is set to air on Nebraska Public Media April 5, 2023, at 7:00 pm. It will also be available on NPM's website and the NEOC will have access to it as well.

Director Watson let the Commission know that he submitted to the governor a proclamation request for Fair Housing month (April), but he has not heard back yet on the status of that request.

The Lincoln Commission on Human Rights is holding its annual conference April 19, 2023. Commissioners are welcome to attend and are to let Director Gardner know if they would like to attend. It was noted that Investigator Sophie Belter was invited to participate on a panel for one of the conference sessions.

3. Director's Report – Executive Director, Paula Gardner

Director Gardner introduced Investigators Jane Skinner and Lily Saker who are working out of the Omaha office. They both come to us from other state agencies and we are excited to have them join us. In order to accommodate the additional Investigator in Omaha a cube area is Omaha is be reconstructed.

Rebekka Hergenrader has moved into our Administrative Technician position for the Lincoln office. Lexi George was hired to fill Rebekka's open Office Specialist position and is expected to start Monday, March 20, 2023.

There is one more open Investigator position in Lincoln that we have interviewed for with some great applicants. We expect to extend a job offer next week.

Director Gardner mentioned we are still working on updating our database and website.

4. Legislative Update—

Director Gardner reported she has testified in a neutral capacity for the bills previously identified. By testifying neutrally she was able to clarify some issues brought up from other testifiers on various bills since those who testify in a neutral capacity testify last.

The only bill that had any follow up from anyone was on LB169, which amends various statutes, including FEPA, to include gender identity and sexual orientation. The business community is very supportive of this bill and contacted Director Gardner with some questions following the hearing.

Director Gardner will continue to monitor all the bills.
