2. Outreach Report—Unit Director, Ben Watson

Director Gardener discussed the training Director Watson organized with a state agency, upon their request, as part of the agency's annual training program.

Director Gardner stated that we received the Fair Housing Proclamation from the Governor that was shared with other agencies, including HUD, OHRRD, LCHR, Realtors Association, and the Fair Housing Center.

Director Gardner announced staff participated in the EEOC virtual conference April 15-17, and will be participating in the LCHR in person conference on May 1, 2024.

Director Gardner reported Director Watson will be joining the EEOC in Macy NE, on May 2, 2024, for an in-person presentation and listening session for the Omaha tribe.

3. Director's Report – Executive Director, Paula Gardner

Director Gardner stated an investigator left for the private sector the end of March. They will be conducting interviews April 29th, 2024, for the two open Investigator positions, with the tentative start date in mid-May.

Director Gardner indicated we will start conducting quarterly all staff meeting virtually, as well as continuing with the annual staff meeting one of the quarters. The first one is scheduled for May 7, 2024.

Director Gardner remarked she asked the Unit Directors to meet with investigators two times a month as opposed to once a month and will be initiating meetings with non-investigator staff and Unit Directors once a month as well to discuss the work being done, challenges, and opportunities.

Director Gardner mentioned she received notice this week that Tyler Technologies is ready to start the website transition.

Director Gardner announced the Public Hearing was conducted on March 27, 2024, that Commissioner Arnold attended. We received the transcript, and the hearing officer will be reviewing everything prior to issuing their recommended order for the commissioners.

Director Gardner stated she is still waiting for EEOC audit exit meeting. They should be done shortly, and then will schedule the exit meeting.

Director Gardner previously mentioned the MOU with OHRRD. That is currently on hold as Director Gardner had concerns about the NEOC being designated as a contractor and the obligations the city was imposing as a result of that designation. As we are not a contractor providing any work or services to the City, other options for the MOU are being explored.

Director Gardner observed no action taken on legislative bills this session that directly impacted the Agency.


