Director Watson has indicated that the NEOC will be participating in the Nebraska Disability Pride Celebration in Antelope Park on July 27, 2024.

Director Watson shared that plans for Brandie Hinkle to hold workshops at Heartland Workforce Solutions are being finalized. Heartland Workforce Solutions is a non- profit workforce that help people get employed and stay employed, which part of that will include understanding employee rights, our process, etc. We are also looking into potential job fairs and other events we can attend.

Director Watson announced that he has been communicating with institutions of higher education in Nebraska. As the Fair Housing Act applies to dorms on campuses, this specific subject will be beneficial to colleges and universities. He Plans to visit Midland University in July; the exact date has not been established.

5. Director's Report - Executive Director, Paula Gardner

Director Gardner introduced new Omaha investigator Isaiah Kluver. She also announced that Lincoln investigator Bridget Price has given notice that she will be leaving in July. With the open investigator position she hopes to be able to hire from the previous applicant pool to have someone starting July 15th.

Director Gardner stated the hearing officer is working on the Recommended Final Order and expects it sometime this summer.

Director Gardner discussed the final meeting with EEOC regarding the audit. There are no areas of concerns at this time. We will continue to work closely with our state and local program manager to ensure we are in compliance with the agreement. The contract from EEOC increased about 30 cases from last year.

Director Gardner announced that two housing investigators will be attending the National Fair Housing Alliance conference in Washington, D.C. July 14th to July 16th. And the other two housing investigators will be attending the International Association of Official Human Rights Agencies in St. Louis, MO August 11th to August 15th. These training are required and approved by HUD.

Director Gardner announced that the new Case Management System is expected to launch July 1st.

Director Gardner stated that she and Cathy Fedor have been training for the upcoming budget, that will start in July with final submissions due September 15th.
