2. Outreach Report—Unit Director, Ben Watson

Director Gardner announced Cathy Fedor was hired for the Business Manager position. Cathy was the Admin Tech in Omaha and has extensive accounting experience from her work with city entities in Las Vegas. The position is an overlap position so Kathy Bogenreif can train her while she is still employed through the end of the year.

Director Gardner invited the commissioners to Kathy Bogenreif's party retirement party.

Director stated the admin tech position in Omaha has been posted and they will begin interviewing for it next week

Director Gardner indicated the website is about 66% done, and a lot of progress has been made on the database.

HUD has approved the Commission's outreach proposal for this year. The Commission will be working with a local TV channel to produce and air two commercials that will reach an audience outside of the Lincoln and Omaha area. The Commission will also retain ownership of the commercials to use elsewhere if wanted.

Director Gardner announced a Public Hearing case in Omaha in December. In the past a Commissioner has attended and reported back to the Commission as they have to vote on the Hearing Examiner's final order. Commission Arnold and Kosmicki indicated they may be available and to let them know as it gets closer.

Director Gardner discussed the commission packets. History of the mailing of the packets was given. Director Gardner discussed having one mailing and the timing of that mailing. It was agreed to move forward with having one mailing.
