Director Gardner discussed the announcement of the state budget shortfall. All agencies have been asked to cut 5%. Cathy Fedor has been working diligently to operate within our budget, and we will be able to realize the 5% savings requested. These reductions will likely also impact the upcoming biennium budget process that is to be completed by September 15, 2026.

Director Gardner announced hiring a new investigator starting in Omaha on Monday, July 20, 2026.

Director Gardner stated EEOC contract is entering its final quarter, and the agency is requesting an upward modification. Any granting of an upward modification will likely not be known until later in August.

Director Gardner conveyed that the agency still doesn't have a HUD contract, but HUD seems to be moving forward as they have in the past in reviewing case closures from July 2025 through June 2026. In the meantime, the agency will continue to operate business as usual with HUD.

Director Gardner announced Commission Meyer has been formally reappointed, and we are still waiting to hear about the reappointment of Commissioner Borchers. Commissioners Arnold, Jeffries, and Weddle's appointments end in September. Those Commissioners interested in seeking reappointment are to let Director Gardner know before the next meeting. If Commissioners have anyone they believe would be a good match for the Commission, they are encouraged to share with that individual how to apply for consideration for appointment.

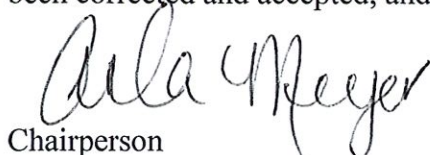
